Fire Safety and Insurance News

- Though unable to attend BHA's annual meeting, District 5 Supervisor Jessica
 Pyska prepared a number of updates for us. Her letter is attached to this email.

 She continues in her efforts to press the Department of Insurance to respond to our needs and concerns.
- Leaders from Buckingham and neighboring communities met with Rep. Mike
 Thompson in late June to discuss the insurance crisis in Lake County. Local

- insurance survey data was compiled to be shared with him and other federal officials. As a result of this meeting, **Rep. Thompson will be advocating for us at the federal level and seeking funding to assist with local mitigation work.**
- 5 properties are expected to be cleared by the county **Benefit Zone** within 6 weeks. County is currently working to secure the warrants that will allow them to enter these properties and begin clearing.
- A whopping 150 tons of fuel were removed from 115 lots participating in our late spring chipping program!
- John Nowell, retired battalion chief and member of the Konocti Fire Safe Council, delivered an important and powerful presentation on Zone 0 defensible space and home hardening. Stay tuned for a separate email about maintaining this crucial fire-prevention zone.
