Annual Disclosures & Dues

Our annual disclosure packet was mailed out at the end of May. If you signed up for electronic notices, the packet was sent by email, in PDF format.

Dues invoices have also been mailed (separate from the packet this year) or emailed (if you signed up for electronic delivery). If you wish to pay by credit card, we strongly encourage you to sign up for electronic notices. This allows us to send you the invoice (and annual packet) by email, along with a link to make your payment online.

Opting for electronic delivery helps us save on mail-related costs: paper, printing, postage, and labor. This is one of the biggest expenses that you can DIRECTLY help reduce, which in turn helps keep our dues low. You can find the electronic delivery signup form attached to this email. If you have already signed up, thank you – you do not need to resubmit this form annually.

Fire/Weed Abatement

Thanks to everyone who has cleared their properties in anticipation of fire season! Thanks also to our chipping lottery participants – this is only the second time we've offered free chipping to the community, so we've had a lot to learn! We appreciate your patience through this process and value your feedback as we finetune our program for the future. Chipping is scheduled to begin on Monday, June 17th.

REMEMBER: abatement compliance must be maintained through November 30th. Visit our website for <u>Guidelines & Abatement Services</u>.

- Grass and weeds must be no taller than 3 inches.
- Dry brush must be more than 30 feet from the road.
- Dry brush must be more than 100 feet from any structure.
- Dead trees and branches must be removed from property.
- Flammable material must not be in contact with a structure or under a deck.
- Tree limbs must be more than 6 feet from the ground.
