Out-of-Town Tips

Let your neighbors know when you'll be gone so someone can keep watch for you. If you don't feel comfortable asking a neighbor, contact the BHA office to coordinate with the neighborhood watch.

Vacation checks can also be arranged with the Sheriff's Office. This service consists of free, periodic checks of your property for up to 30 days. Your request must be made at least 3 weeks in advance: <https://lakesheriff.com/1055/Vacation-Checks>

Who do I contact when ... ?

Did you know? **When the authorities are aware of our community's problems, they're more likely to dedicate resources to preventing and solving them.** With the majority of problems thankfully elsewhere in the county, we don't have much of a patrol presence in Buckingham. That's why reporting suspicious/criminal incidents to the authorities is crucial – **they can't know what we need unless we tell them what's going on.** Here's the breakdown of where to report what:

- EMERGENCY – **call 911 immediately.**
- NON-EMERGENCY – contact the **Lake County Sheriff's Office** at **(707) 263-2690** or [file a report online](#). (We are happy to assist you with filing online.)
- ALL CASES – you may also contact the **BHA office** to coordinate efforts with the watch group, but your **FIRST** priority should be contacting the authorities.
